**Broad-Based Black Economic Empowerment (B-BBEE) Status: Ingelby Water Purification CC

To whom it may concern !

IntegriBBBEE CC and specifically Mr. I. A. Reisinger, an accounting officer duly registered with the South African Institute of Professional Accountants, has been engaged by Ingelby Water Purification CC as an independent, outside, 3rd party consultant/facilitator to advise and assist the closed corporation in regard to its Broad-Based Black Economic Empowerment initiatives.

In this regard and based upon the attached confirmation issued by Genesis Chartered Accountants, the accounting officer of Ingelby Water Purification CC, the closed corporation achieved a turnover for the financial period **01 March 2009 to 28 February 2010** of below **R 5 million**. As Ingelby Water Purification CC has not exceeded the abovenamed threshold as stated in terms of the Broad-Based Black Economic Empowerment Act No. 53 of 2003 and the attaching Codes of Good Practice as issued under section 9 of the same Act, it is considered an **Exempt Micro Enterprise**.

Ingelby Water Purification CC has **no Black Ownership** credentials, is **not an Enterprise Development Recipient** and is **not** considered a **Value-Adding Enterprise**, as its Nett Profit Before Tax (NPBT) summed with its Total Labour Costs does not exceed 25% of the value of its Total Revenue.

IntegriBBBEE CC can herewith confirm that Ingelby Water Purification CC is considered a Superior Contributor towards Broad Based Black Economic Empowerment by having achieved a B-BBEE Status of Level 4 i.e. by the nature of the level of its annual turnover having accorded it an Exempt Micro Enterprise status as defined in terms of the Broad-Based Black Economic Empowerment Act No. 53 of 2003 and the attaching Codes of Good Practice as issued under section 9 of the same Act. This makes Ingelby Water Purification CC 100% compliant in terms of the B-BBEE recognition levels as contained in the Codes of Good Practice under section 9 of the B-BBEE Act.

This confirmation, of the B-BBEE status achieved by Ingelby Water Purification CC, is valid for the twelve month period: **01 March 2010 to 28 February 2011**.
